

# **KEY HIGHLIGHTS**

- Till now 22 states have pre-published draft rules on for all four codes.
- Out of 36 states, there are 5 states will have pre-published drafts of only three codes.
- Andaman & Nicobar is only state that have pre-published only two codes.
- There are 3 states including Delhi which have published only one labour code.
- There are 5 states which are yet to prepublish any of the labour code.

## **Greetings to our Readers!!!**

The four labour codes namely The Code on Wages 2019, The Industrial Relations Code 2020, The Code of Social Security 2020 and The Occupational Safety, Health and Working Conditions Code 2020 are set to replace 29 labor laws.

With most of the states are ready with draft rules, the view in the Labour Ministry is converging towards a "one-go" or simultaneous implementation of all four codes even as there are some concerns about the timing of the rollout.

Since many states have pre-published draft rules, The Minister for Labour and Employment was recently quoted as indicating that the Codes would be made effective not later than 2023. In view of the above observation, the organizations must take immediate actions to prepare themselves for the implementation of the Codes. Accordingly, they must be ready to analyze the salary structure and revise the same considering the overall financial impact. In addition to the above, the labour codes require immediate attention on drafting of appointment letter and identification of core and non-core activities for all manufacturing business. Further, it is important for all organizations to align Human Resource Policy as per codes emphasizing on the benefits provided to fixed term employees, women workers and contract workers.
